Symposium Net & Gross to date (Melissa, Tim and Lyndsey)

- Slightly updated numbers
 - Coding for staff times, spreadsheets were a little different between Melissa and Tim but very close.
- \$13,370 in registration.
- \$40,100 in sponsorships.

- \$18,000 in expenditures (just under).
- \$35,000 in the positive (about).
- Best sponsorship levels to date
 - Committee is discussing how to retain this current level of sponsorship involvement.
- The symposium committee has lost some committee members.
 - Soliciting for additional Symposium Committee members, email Melissa if you'd like to join.

Update on Native Grass Guidebook

- Put out proposals for website consultant.
 - o 3 proposals were received.
 - In final stage of interviews and group review.
- Should be accepting one proposal and moving forward before the end of 2023.
- 5-month project timeline from website developer
 - CWW was hoping to launch in March (2-month disparity)
 - Pushing to accelerate the project.

Solicit nominations for Management Team

- Brad is rolling off management to participate more in committee work.
- Tim and Lyndsey will stay on as co-treasurers.
- Secretary position has 2 people voicing interest.
- Discussion on co-chair
